Explanations

Travel costs: Flat-rate travel allowances help cover the costs of the return journey from the place of residence to the location where the activity takes place. As a rule, public transport should be used.

Organisation costs: Organisational support allowances contribute to project costs, such as accommodation, meals, equipment etc.

Special needs costs: Up to 100% of the costs associated with the participation of people with disabilities may be claimed, e.g. special transportation for wheelchair-users. The estimated amount should be requested in the application and the final expense claim should be based on actual costs as per supporting documents.

Exceptional costs: Any visa costs, vaccination costs, compulsory insurance costs for entry or direct costs associated with participants with fewer opportunities that are incurred during the project may be claimed in full. "Participants with fewer opportunities" refers to young people facing financial, social, cultural, educational or geographical obstacles which hinder their integration into society and their access to mobility.

Exceptional costs also include the accommodation costs for an Advance Planning Visit (for Youth Exchanges and EVS only).

The estimated amount should be requested in the application and the final expense claim should be based on actual costs as per supporting documents.

Individual support/allowance (EVS only): These allowances are designed to cover the personal expenses of EVS volunteers.

Linguistic support costs (EVS only): Where there is a justified need, a flat-rate allowance to improve language skills before or during a volunteer assignment can be applied for (only for mobility projects lasting between two and 12 months).
